When installed and maintained properly, DuraKwik Stone products will provide pleasing look to your property. Keep them looking new and provide them with protection from the environment.

COVERAGE:

DuraKwik Stone warrants the original purchaser of the DuraKwik Stone products at the time of purchase and 25 years thereafter. Warranty is nontransferable to other subsequent property owner.

DuraKwik Stone warrants the product from our products are free of manufacturing defects such as material and workmanship. Manufacturing defects include: peel, rot or corrode.

Upon receipt of the warranty claim request in form of claim form, DuraKwik Stone will validate and accept claim. Upon claim validation, DuraKwik Stone will at its discretion execute the claim with one of the following options:

- Provide needed accessories to repair the related defect product portion.
- Replace the defect product portion.
- Refund the purchase price of the defect product portion per the Coverage Proration Schedule below.

NOT COVERED:

- Damages caused by misuse, negligence or improper installation
- Discoloration or other damage caused by normal weathering, air pollution, mold, mildew, exposure to harmful chemicals and exposure to uneven sunlight over extended long period of time
- Product discoloration or deterioration due to unpainted polyurethane cut surfaces
- Labor or installation costs for replacement or repair for the affected area
- Improper handling, shipping, or storage of product
- Alterations like applying incompatible coatings or stains
- Product that has been painted over or altered without written authorization from DuraKwik Stone
- Fire
- Settlement
- Warping or distortion due to exposure to excessive heat source

- Impact of foreign objects
- Lighting, hurricane, tornado, windstorm, hail, or other acts of God
- Misuse and abuse of product
- Failure to follow the recommended maintenance steps, especially not applying touchup paint when exposed area is not covered with recommended touchup paint
